# **1. BACKGROUND INFORMATION**

## **1.1. Contracting Authority**

Together for Life (TFL), Rr. Brigada e VIII-tw, Pll. Jeshil, Shk.2, Al. 14, Tirana, Albania

### **1.2.** About the organization

"Together for Life" (TFL) association is a non-political, nongovernmental and not-for-profit organization, established in late 2009 as an initiative of a group of reputable journalists as a membership organization; focusing on the development and empowerment of people. TFL has solid experience and expertise in the field of health and has implemented national projects aimed at: improving citizens' access to health services; increasing the level of knowledge and information of population and medical staff about the patient rights card; improving the quality and specific aspects of health services; improving the infrastructure of some health centres in isolated areas of the country; organization of health promotion campaigns in remote areas of northern Albania in order to increase the knowledge and awareness of the population regarding their health; monitoring and corruption in the health system and encouraging citizens to report and denounce any case of corruption. These initiatives are supported by various donors such as USAID, the US Embassy in Albania, the foundation "Open Society for Albania", HAP / SDC, UNFPA etc.

### **1.3.** About the TFL project

Since February 2021, TFL is implementing the project "Reintegration of the Returnees by increasing access to health care and improving their health", supported as part of the Returning to New Opportunities Programme of the German Federal Ministry for Economic Cooperation and Development - GIZ.

The project is conceptualized in two phases that proceed in parallel:

*Firstly*, to increase capacity of the general practitioners' /family doctors and representatives of Labour Offices on identification and provision of services for the returnees, that need first to register to primary care services for basic care. The project will collaborate with health personnel, focusing on the General Practitioners as first encounter with the health system, and also the representatives of Labour Offices in Lezha and Elbasan.

*Secondly*, proposes to organize ten information sessions on the health care system and referral system with the selected target group of Elbasan and Lezha. Primary target will be the families of the returnees, aiming to empower them on helping their family members to take care of their health as a requisite to employment opportunities.

## 2. OBJECTIVE, PURPOSE & EXPECTED RESULTS

### 2.1. Overall objective

The Objective of the assignment is:

We are looking for one expert to work (in collaboration with two experts in the health field) on this assignment "Assessment of health-related factors affecting returnees and potential asylum seekers". Expert should have University degree and at least two years of activity in the migration field.

The goal of this activity is to conducting an initial assessment with returnees and potential asylum seekers, to understand the health-related issues they face, and if are reasons for leaving.

The expert will work closely with two others experts, in consultation and coordination with the project team.

The expected results and deliverables of this assignment are:
